1. Objective of HIP 5: Medical Devices Initiative

To create a minimum of ten (10) home grown champions in Medical Devices Industry through a targeted approach by building up the capability and capacity of participating companies through development programmes, provision of market intelligence and enhancement in market access to create high growth Small and Medium Enterprises (SMEs) in accordance to the High Impact Programmes 5 (HIP 5): Catalyst Programme of the SME Masterplan.

2. Objective of Accelerator Programme (AP)

- 2.1. To accelerate the development of a pre-selected group of 10 Malaysian SMEs in the medical devices sector by expanding their capabilities and capacity in order to further enhance their ability to be part of global supply chain;
- 2.2. This programme will provide a hands-on training programme, coaching as well as support for 10 participating SMEs for them to be more competitive in the medical devices sector. This programme should also aims to enhance capacity building and to assist companies in formulating the international marketing strategies.

3. General Scope of Work

- 3.1. Developing AP training module. The AP modules must include seminar, business coaching, company visits and formulation of strategic action business plan for each SMEs; and
- 3.2. Implementation plan development and support including, building internal capabilities, tangible action plans to move up the value chain.
